#### **About This Document**

This document tracks and shares local agency best practice activities completed and counted as part of a city or county's participation the climate change and sustainability recognition program, the Beacon Program. The Beacon Program is a statewide program recognizing cities and counties that are working to reduce greenhouse gas emissions, save energy and adopt policies and programs that promote sustainability.

The Beacon Program is sponsored by the Institute for Local Government and the Statewide Energy Efficiency Collaborative. The Statewide Energy Efficiency Collaborative (SEEC) provides support to cities and counties to help them reduce greenhouse gas emissions and save energy. Silver	The city participates in the emPower Central Coast Program. emPower Central Coast provides free faucet aerators and water-efficient shower heads to residents during Energy Coach site visits as well as community events. The faucet aerators and low-flow shower heads are provided by Southern California Gas Company.	2016

Gold	<ol> <li>The city installed a Community Demonstration Garden next to Ojai City Hall on Ventura Street. The garden provides an educational experience via an interpretive self-tour that displays drought resistant plants, wildlife habitats, and natural growing methods including composting and an organic vegetable garden. A primary focus of the garden is waste reduction and water conservation. Semi-annual presentations demonstrate that through composting and mulching, what we have come to know as waste, can actually be a beneficial resource. Organic garden and orchard demonstrations show how beautiful landscapes and productive agriculture can be achieved without the use of toxic chemicals. Habitat and resource conservation demonstrations inspire preservation of local natural resources and encourage participants to enjoy living in a harmonic, interconnected system with nature. The garden is open to the public every day from dawn to dusk and there is no cost to visitors and all workshops are free.</li> <li>The city offers periodic workshops at the Community Demonstration Garden on various topics such as waste reducing, natural pruning methods, low flow irrigation and tree maintenance. Upcoming workshop dates are posted on the garden bulletin board.</li> </ol>	2016

The emPower Program includes an Energy Coach service where coaches spend up to two hours with a homeowner at their residence providing them with information on green building techniques and recommendations to improve their home's energy efficiency. Gold	<ol> <li>The city offers instructional information on their website for backyard composting and grasscycling: http://ojaicity.org/solid-waste-and-recycling/. Composting and grasscycling improve soil structure as well as release valuable nutrients back into the soil. Both techniques also help reduce over watering lawns and gardens.</li> <li>In 2012, the city adopted Ordinance No. 817: Single-Use Carryout Bag Ordinance. Retail establishments must stop distributing single-use carryout plastic bags, and grocery stores (including supermarkets, convenience stores, liquor stores, and gasoline stations) must begin charging ten-cents for recyclable paper carryout bags: http://ojaicity.org/single-use-carryout-bag-ordinance/.</li> </ol>	2017

Platinum	<ol> <li>The City of Ojai has a Construction and Demolition Debris Recycling Program on their website that provides detailed instructions on how to implement and certify a Waste Reduction and Recycling Summary: http:// ojaicity.org/solid-waste-and-recycling/</li> <li>The city partners with the County of Ventura to offer free ongoing electronics recovery programs and drop off sites for e-waste and household hazardous waste disposal. The City also provides information on their website for used oil and oil filter recycling: http://ojaicity.org/solid- waste-and-recycling/.</li> <li>A total of 11,803 passenger car tires were recycled as rubberized asphalt for the City's Road Rehabilitation Project completed in December of 2015. Various streets throughout the city benefited from this project. The project was funded by a grant from the Department of Resources Recycling and Recovery (CalRecycle). The grant program promotes markets and recycled-content surfacing products derived from waste tires generated in California and decrease the environmental impacts created by unlawful disposal and stockpiling of waste tires: http://ojaicity.org/waste-tires- recycled-through-street-paving-project/.</li> </ol>	2017

The city participated in Southern California Association of Governments (SCAG) development of the Regional Transportation Plan and Sustainable Communities Strategy (RTP/SCS), in compliance with SB 375.The addition of the sustainable communities strategy to the RTP means that the RTP now integrates not only transportation and land-use planning, but also housing and environmental planning with the goal of reducing regional greenhouse gas emissions. The city uses the RTP/SCS when conducting its own transportation, land use, and environmental planning to assist in efforts to reduce regional greenhouse gas emissions.	2016

Gold	<ol> <li>In 2014, the city first offered CaliforniaFIRST energy financing program for residential, commercial, industrial and multifamily property owners to install energy efficient retrofits, solar photovoltaic, or hot water systems on new or existing buildings.</li> <li>As part of the general plan housing element update, the city identified potential infill development sites, and maintains a community-wide database of vacant and underutilized infill sites to monitor the community's growth and change.</li> </ol>	2016

For example, the city participates on an advisory working group for implementing a community choice aggregation program in Ventura County.</li> <li>Since 2014, the city has participated in a regional climate action partnership with the County of Ventura, VCREA, and the cities of Camarillo, Fillmore, Moorpark, Oxnard, Port Hueneme, Santa Paula, Simi Valley (joined in 2016), Thousand Oaks, and Ventura. This partnership resulted in the development of the Climate on the Move Report.
